**CONSENT ORDER**

WHEREAS the North Carolina Respiratory Care Board (the "Board") is charged with the administration of The Respiratory Care Practice Act, codified in the North Carolina General Statutes at G.S. 90-646 et Seq. (the "Act"); and

WHEREAS the Board conducted an investigation pursuant to G.S. 90-652 (5) into the activities of Licensee to determine if she has violated, is violating, or is about to violate any provisions of the Act; and

WHEREAS during a Board Investigation it was found that Beverly Edgerton had violated a lawful order of the Board in violation of G.S. 90.659(a)(4) and 21 NCAC 61.0309(d)(14)(n); and

WHEREAS on April 5, 2005 the Investigational and Informal Settlement Committee of the Board, acting pursuant to 21 NCAC 61.0203, conducted an interview of Beverly Edgerton; and

WHEREAS the Board met on April 7, 2005 and determined to issue a Consent Order to Beverly Edgerton with conditions; and

WHEREAS Licensee agrees to the entry of this Consent Order, and voluntarily agrees to waive any rights to a hearing upon entry of this Consent Order, and waives the right to seek judicial review or otherwise challenge or contest the validity of this Consent Order,

AND WHEREAS upon the entry of this Consent Order, this matter will be resolved with the express understanding that the Licensee will comply with all of the terms contained herein.

**NOW THEREFORE, IT IS HEREBY ORDERED THAT:**

Beverly Edgerton shall continue to comply with the Act, the Board's Rules, and the Board's interpretation of those rules.

Beverly Edgerton agrees to the issuance of a Board Reprimand for her violations of the Act.

Beverly Edgerton agrees to pay to the Board within 90 days from the date of signature of the consent order the sum of \$140.00 (\$150.00 minus a \$10.00 account credit) to pay the cost of disciplinary action as authorized by G.S. 90-666(d).

Entry of this Consent Order by the Board is without prejudice to the right of the Board to take any administrative action against Licensee to enforce this Consent Order if the Board determines that Licensee is not fully complying with any term or condition stated herein; and,

This Consent Order shall become final when accepted by the Licensee and entered by the Board based on the execution by its Executive Director.
