CONSENT ORDER

**IN THE MATTER OF:
MEGAN J. MCINTYRE
RESPIRATORY CARE LICENSE #4835**

WHEREAS the North Carolina Respiratory Care Board (the "Board") is charged with the administration of The Respiratory Care Practice Act, codified in the North Carolina General Statutes at G.S. 90-646 et. seq. (the "Act"); and

WHEREAS on or about May 25, 2006, the Board issued a license to practice respiratory care to Ms. Megan J. McIntyre ("Licensee"), license number 4835; and

WHEREAS the Board received a complaint on January 19, 2007 from Cape Fear Valley Medical Center, alleging that the Licensee had falsified patient records and had exhibited unprofessional conduct related to the delivery of respiratory care; and

WHEREAS the Board conducted an investigation pursuant to G.S. 90-652 (5) into the activities of the Licensee to determine if she has violated, is violating, or is about to violate any provisions of the Act; and

WHEREAS on April 11, 2007, the Investigation and Informal Settlement Committee of the Board, acting pursuant to 21 NCAC 61.0203, conducted an interview of the Licensee to determine the qualifications of the Licensee, and during the course of the interview the Licensee admitted that on the day in question, she was responsible to provide treatment to more than 30 patients, but had only provided 12 treatments; and

WHEREAS the Board met on April 12, 2007 and determined to issue a Consent Order to the Licensee; and

WHEREAS the Licensee agrees to the entry of this Consent Order, and voluntarily agrees to waive any rights to a hearing upon entry of this Consent Order, and waives the right to seek judicial review or otherwise challenge or contest the validity of this Consent Order;

AND WHEREAS upon the entry of this Consent Order, this matter will be resolved with the express understanding that the Licensee will comply with all of the terms contained herein.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

Licensee consents to being licensed to practice respiratory care on Probationary Status for a period of 12 months from the date of signature of this Consent Order.

Licensee shall cause her immediate Respiratory Care supervisor to submit written quarterly reports to the Board, which shall be submitted by the 15th day of July 2007, October 2007, January 2008 and April 2008. Each such written report shall document the Licensee's performance in the delivery of Respiratory Care, and detail any concerns of the supervisor about the Licensee's practice of Respiratory Care.

Licensee agrees to complete a continuing education course recommended by the Board on Medical Ethics. The course must be completed within 90 days from the date of signature of this Consent Order. A copy of the course completion certificate must be forwarded to the Board.

Licensee agrees to pay to the Board within 90 days from the date of signature of this Consent Order, the sum of \$50.00 for Civil Penalties which are authorized by G.S. 90-666(a) and 21 NCAC 61.0309 (d)(1) and the sum of \$250.00 to pay the cost of disciplinary action as authorized by G.S. 90-666(d).

Licensee shall continue to comply with the Act, the Board's Rules, and the Board's published interpretation of those rules.

Entry of this Consent Order is without prejudice to the right of the Board to take any administrative or judicial action against Licensee to enforce this Consent Order if the Board determines that the Licensee is not fully complying with any term or condition stated herein.

This Consent Order shall become final when accepted by the Licensee and entered by the Board based on execution of the Consent Order by its Executive Director.
